Beneficiary Designations

A well drafted Will or Revocable Trust explains who should receive certain assets after death. However, that is not enough to guarantee that everything will go according to that plan.

Unintended beneficiary designations are a very common source of surprises in estate administration.

Life insurance policies and retirement accounts all have some form of beneficiary designation that tells us who will receive the death benefit or account balance after the owner dies. There is nothing that says these beneficiary designations will be the same as the beneficiaries named in

the Will. Indeed, unintended beneficiary designations are a very common source of surprises in the estate planning process.

Our clients generally take responsibility for changing their beneficiary designations to match their will or trust. We provide some guidance, and many financial advisors that we work with are very proactive in coordinating beneficiaries with the other estate planning documents. However, here are some recommendations to ensure your plan will be properly executed:

- Read your beneficiary designations. If you do not understand them, ask for some clarification from your advisors.
- Get a written statement from the company that shows you who is named on all of your beneficiary designations.
- Keep the written record of your beneficiary designations in the same place that you keep your Will or Revocable Trust.

Revocable Trust Assistant

In our Winter 2004 issue, we described how the failure to properly title assets could foil a perfectly good Revocable Trust. Married couples can rely upon a Marital Property Agreement to overcome most of these issues, but most single people bear a greater risk.

We recommended these clients with a Revocable Trust keep good records regarding their assets, confirm that ownership is correct, and follow up on any changes that could jeopardize the plan. Because this can sometimes be easier said than done, we developed the Revocable Trust Assistant Process to specifically address the needs of clients who establish Revocable Trusts.

This process will have our staff get directly involved with:

- The review of your current assets and beneficiary designations;
- Determinations regarding any changes that are required;
- Executing the changes;

• Documenting the final result. We have done this for certain clients whose circumstances require special attention. The Revocable Trust Assistant Process allows us to share the same services with all our clients.
